### TICKETING

#### Director Membership

For each performance week you will receive 2 tickets in the front 3 rows of the Dress Circle. For shows running for more than a week the weekly ticket allocation can be accumulated and used for one performance. A complimentary programme is provided with each ticket.

#### Fellow Membership

For each performance week you will receive 4 tickets in the front 3 rows of the Dress Circle. For shows running for more than a week the weekly ticket allocation can be accumulated and used for one performance. A complimentary programme is provided with each ticket.

Tickets are reserved via the dedicated Laidler Club bookings staff. Should you require additional tickets these can also be purchased through the Laidler staff and will, wherever possible, also be in the front 3 rows of the Dress Circle. Any additional tickets purchased will be invoiced on a monthly basis. This includes the VIP Pass for the Laidler Lounge VIP Bar.

### MEMBERSHIP FACILITIES

The Laidler Lounge VIP bar is available for the use of Laidler members & guests. Members receive a glass of champagne or soft drink on arrival.

There is a 10% discount off food, and drinks post show.

## TERMS AND CONDITIONS OF CORPORATE MEMBERSHIP OF THE LAIDLER CLUB

From the date of commencement of Membership the Theatre agrees to:-

1. Credit the company for sponsorship and support, on the inside of every programme produced by the Theatre, during the period of membership. This is subject to printing schedules and the company providing their own logo and artwork for this page.
2. Provide 2 tickets for Director Members and 4 tickets for Fellow Members for each week of productions. For productions that run longer than one week, your ticket allocation can be accumulated. Tickets will be "best in the house" Dress Circle seats, or a suitable alternative, at the General Manager's discretion. Additional tickets may be purchased through the Laidler Club Administrator and wherever possible will be "best in the house" Dress Circle seats.
3. Allow members the use of the Laidler Lounge VIP Bar on show days, subject to availability. In the event that the Laidler Lounge is unavailable, a suitable alternative area will be provided.
4. Provide catering and bar facilities for corporate entertaining. All costs for food and drinks will be additional to the cost of membership and the subject of a separate agreement. Should you have a large party, areas within the front of house will be provided free of charge.
5. Provide an exclusive booking line for members with seats reserved and available at short notice, subject to demand and the General Managers discretion.
6. Further annual memberships shall be offered at the General Manager's discretion at an annual fee increase of 2.5%

### **The Laidler Club member agrees to:**

1. Book their ticket allocation and Laidler Lounge places with Bradford Theatre's Box office at least 48 hours in advance of the performance. (this may be amended subject to the Manager's discretion)
2. Place, room, function and restaurant bookings at least 2 weeks in advance (please note that these are subject to availability)

4. Pay membership fees promptly within 14 days of invoice
